Summer 2019 League Footing Academy



The <u>Dripping Springs Ranch Park and Event Center</u> hosted the Summer 2019 Footing Academy 101 on May 21-22 in Dripping Springs, TX and there were nearly 30 participants who attended.

"I had wanted to have a Footing Academy here in Texas because there are a lot of members in the area," explained League Board Member Lynne Dickinson who runs the Dripping Springs Ranch Park. "We had attendees from Texas, Arizona, Missouri, and South Carolina."

First-time Footing Academy attendees received a valuable education. "All of the students brought samples of footing from their facilities," said Jeffery Storms, one of the instructors at the Footing Academy. "We gave them feedback on their footing and ideas on how they might best make changes to improve their footing. We covered the basic types of soil, moisture levels, and depths that are required based on specific disciplines."

Students also had the opportunity to hear from various speakers about the importance of footing, including an equine veterinarian and a few horse show managers. "Our speakers added some great information," Jeffery said. "The veterinarian explained how footing affects the soundness of a horse. The horse show managers spoke to the importance of good footing and how it can make or break your facility economically."

It was a great experience overall with lots of learning. "The group was very interactive, and it felt like everyone learned from the experience," Jeffery added. "I enjoyed sharing my knowledge and helping people learn about improving their footing."

Meet Jay Brower! Jay has been the Fairgrounds Manager of the Sublette County Fairgrounds for about nine years and has been a member of The League since 2012.

"I grew up on a ranch in Idaho and showed horses in AQHA," Jay said. "I also did rodeos and rode saddle broncs. I was working as a journeyman electrician at the Sublette County Fairgrounds, and the manager was retiring. The manager found out about horse background, electrical license, and experience in the fair industry, and he suggested I apply for the job. I've been there ever since."

When Jay first joined The League, he made instant connections and had a wonderful experience at The League Footing Academy 101. "We were looking to grow our events and improve our facility," he



How to Write a Rock-Solid Contract

Attorney Melissa Wesfall joined us at the 2019 League Symposium to lead a session on contract writing. Melissa offered a variety of tips to consider when renting out your facility:

- A contract traditionally consists of three key parts: 1) Offer 2) Acceptance 3) Consideration
- Don't use a one-size fit all contract.
- If you are leasing out an event space, consider how many people are they having and how many people are you allowed to have in your facility.
- Consider fire codes and potential property damage.
- Know the lessee's requirements and your own limitations.
- Remember to review insurance requirements.

- Have a plan in place for emergencies.
- Question everything in your contract!

"We have created a brand-new style of product for the roping industry," explained Sales Representative Chad Dickey. "We designed a <u>fully automatic roping chute</u> that doesn't require electricity nor compressed air. Instead, the system runs on a battery charged by solar power. It is self-loading and operated by a weight system. When the animal steps into the shoot, a weight system triggers the backgate to close. When the roper is ready to go, someone pushes the button on the remote control."

Aside from their automatic roping shoots, Chute Help also makes manual roping shoots and a plethora of other products. "We offer full area packages, including various types of automatic and manual roping shoots, gates, panels and cattle holding pens," he said. "Our goal is to meet the needs of our customers and we are continuously working on expanding our product line."
